Chief Procurement Officer:

In accordance with provisions contained in South Carolina Code Section 11-35-4210, as amended, Matrix Construction Co., Inc. is protesting the notice of intent to award the above identified project to Melloul-Blamey Construction on the grounds that they were not properly licensed at the time of the bid. To self perform or supervise both concrete and structural framing as set forth under South Carolina Code Section 40-11-410, a general contractor must be properly licensed in each of those subclassifications in order to be legally qualified to perform that work.

During the period prior to the bid opening, OSE issued a total of three different bid forms specifically addressing the listing of proposed subcontractors. Along with the second bid form, OSE issued a one page clarification of South Carolina Code Section 40-11-410, spelling out the South Carolina Department of Labor, Licensing and Regulation's interpretation of Section 40-11-410 which is that BD licensed commercial building contractors could not perform Concrete under subclassification CT or Structural Framing under subclassification SF under a BD license. That same notice from OSE stated that if a bidder listed an unlicensed contractor for the subcontractor listing requirements which included Concrete (CT) and Structural Framing (SF) that the bidder would be deemed non-responsible since an unlicensed or improperly licensed contractor could not legally perform that work. The notice also stated that the proper license had to be obtained prior to the bid opening.

Our investigation showed Melloul-Blamey as having a BD-5 license only at the time of the bid opening and therefore could not legally perform the concrete or structural framing work on this project at the time that the bids were submitted.

We understand that without the proper sub-classification licenses, the only way to legally perform this work is to use properly licensed subcontractors. We were operating under these assumptions when we bid this job. In fact, Matrix Construction obtained a CT license prior to bid and arranged for a licensed SF subcontractor to perform the structural framing in making our bid. Upon further investigation, it was revealed that none of the other General Contractors who submitted bids were properly licensed to supervise Concrete (CT) and Structural Framing (SF).

The classifications for Concrete (CT) and Structural Framing (SF) were included in original OSE bid form in the section of the bid form for listing subcontractors. We know that the costs for both concrete and structural framing work on this project each exceeded 3% of the projected bids for the project and therefore that these two classifications were required to be listed under South Carolina Code Section 11-35-3020(b)(i). The evening before the bids were opened, the bid form was changed to delete the subcontractor listed for CT and SF. We have to wonder why the OSE bid form was changed at the last minute to delete the listing of both CT and SF subcontractors after such a big deal was made of it and also because those classifications were required to be listed for this project under South Carolina Code Section 11-35-3020(b)(i). Nonetheless, bidders had to have the proper license to self perform concrete and structural framing or had to have agreements with subcontractors with the CT and SF classifications at the time that the bids were submitted in order for those bidders to be qualified to perform the concrete and structural framing on this project.


We are asking the OSE verify they are in agreement with South Carolina LLR's interpretation of South Carolina Code Section 40-11-410, (see attached clarification letter) and that OSE determined prior to the issuance of the notice of intent to award the contract that Melloul-Blamey was legally capable of performing the concrete and structural framing work at the time that the bids were submitted. Specifically, we are asking that Melloul-Blamey provide written documentation to OSE that either Melloul-Blamey held licenses for both concrete (CT) and structural framing (SF) or that they had agreements in place with subcontractors who held those licenses at the time that the bids were opened. If Melloul-Blamey can not provide such documentation, then it is Matrix's position that they were not legally qualified to perform the project at the time of bid opening.

If Melloul-Blamey cannot furnish this documentation, then Matrix is requesting that OSE declare that Melloul-Blamey was non-responsible as an unlicensed or improperly licensed contractor who can not legally perform the work on this project and that OSE withdraw its notice of intent to award the contract for this project to Melloul-Blamey. Matrix is also asking that the same inquiry be made of Lazer Construction which was the second lowest bidder on this project. If Lazer can not provide adequate documentation to establish that it was legally capable of performing the project as of the time of bid opening, then their bid should also be rejected since they would also be considered as non-responsible. Finally, if the bids of both Melloul-Blamey and Lazer are rejected for the reasons outlined in this letter, then Matrix is requesting that the contract for the project be awarded to Matrix since Matrix can clearly demonstrate that it was properly licensed for the concrete work and had an agreement with a properly classified subcontractor for the structural framing at the time that the bids were opened. As such, Matrix

was the lowest responsive and responsible bidder and should be awarded the contract for this project under SC Code Section 11-35-3020(c).

1. Section 7 of the Bid Form sets forth a list of subcontractor specialties for which bidder is required to identify by name the subcontractor(s) Bidder will use to perform the work of each listed specialty. Bidder must identify only the subcontractor(s) who will perform the work and no others.
2. For purposes of subcontractor listing, a Subcontractor is an entity who will perform work or render service to the prime contractor to or about the construction site. Material suppliers, manufacturers, and fabricators that will not perform physical work at the site of the project but will only supply materials or equipment to the bidder or proposed subcontractor(s) are not subcontractors and Bidder should not insert their names in the spaces provided on the bid form. Likewise, Bidder should not insert the names of sub-subcontractors in the spaces provided on the bid form but only the names of those entities with which bidder will contract directly.
3. Bidder must only insert the names of subcontractors who are qualified to perform the work of the listed specialties as specified in the Bidding Documents and South Carolina Licensing Laws.
4. If under the terms of the Bidding Documents, Bidder is qualified to perform the work of a specialty listed and Bidder does not intend to subcontract such work but to use Bidder's own employees to perform such work, the Bidder must insert its own name in the space provided for that specialty.
5. If Bidder intends to use multiple subcontractors to perform the work of a single specialty listing, Bidder must insert the name of each subcontractor Bidder will use, preferably separating the name of each by the word **"and"**. If Bidder intends to use both his own employees to perform a part of the work of a single specialty listing and to use one or more subcontractors to perform the remaining work for that specialty listing, bidder must insert his own name and the name of each subcontractor, preferably separating the name of each with the word **"and"**.
6. Bidder may not list subcontractors in the alternative nor in a form that may be reasonably construed at the time of bid opening as a listing in the alternative. A listing that requires subsequent explanation to determine whether or not it is a listing in the alternative is non-responsive. 7. If Bidder is awarded the contract, bidder must, except with the approval of the owner for good cause shown, use the listed entities to perform the work for which they are listed.
8. If bidder is awarded the contract, bidder will not be allowed to substitute another entity as subcontractor in place of a subcontractor listed in Section 7 of the Bid except for one or more of the reasons allowed by the SC Code of Laws.
9. Bidder's failure to insert a name for each listed specialty subcontractor will render the Bid non-responsive.

- b. **LIQUIDATED DAMAGES:** Bidder further agrees that from the compensation to be paid, the Owner shall retain as Liquidated Damages the sum of \$200.00 for each calendar day the actual construction time required to achieve Substantial Completion exceeds the specified or adjusted time for Substantial Completion as provided in the Contract Documents. This sum is intended by the parties as the predetermined measure of compensation for actual damages, not as a penalty for nonperformance.

§ 10. AGREEMENTS

- a. Bidder agrees that this bid is subject to the requirements of the law of the State of South Carolina.
- b. Bidder agrees that at any time prior to the issuance of the Notice to Proceed for this Project, this Project may be canceled for the convenience of, and without cost to, the State.

 - i. The installation and hook up of HVAC RTU#4 with Ductwork as it is currently shown in the Add Alt#1 in the Jan 17, 2012 drawings.
 - ii. Painting yellow diagonal striping for path in HVAC Lab Area as shown in the Jan. 17th 2012 drawings
 - iii. The additional installation of HVAC RTU#5 and HVAC #8 with direct grill return, and one 90 degree ducted elbow with a dispersion grill to serve as the supply.

7. If Bidder is awarded the contract, bidder must, except with the approval of the owner for good cause shown, use the listed entities to perform the work for which they are listed.
8. If bidder is awarded the contract, bidder will not be allowed to substitute another entity as subcontractor in place of a subcontractor listed in Section 7 of the Bid except for one or more of the reasons allowed by the SC Code of Laws.
