
ORDERING INFORMATION:

Gases and cylinder rental are priced separately. Contractor pick up and return of empty cylinders to Contractor's possession is included in the \$9.50 delivery charge. Contractor will pick up, fill and return any "Agency Owned" cylinders at the same price as gases furnished in "Vendor Owned" cylinders without any service charge for handling. No rental charge will apply to "Agency Owned" cylinders. Agency may elect to pay rental on a daily or annual basis.

All legal safety requirements must be adhered to before refilling any "Agency Owned" cylinders. "Agency Owned" cylinders will be tested and necessary repairs made to keep cylinders, valves, etc., in satisfactory condition. Hydrostatic testing emblems must be validated by the Contractor and the Agency notified of violations before refilling. Hydrostatic testing is provided and charged on a per test basis. Where cylinder contents are found to be appreciably at variance with the invoiced amount or amount shown on the cylinder tag, the Agency should notify the Contractor to pick-up the cylinder to be checked.

Lost or unreturned "Vendor Owned" cylinders not returned to the Contractor within 60 days after termination of this contract will be charged to the responsible Agency at \$195.00. Damages to "Vendor Owned" cylinders will be invoiced at the current replacement cost. Cost of parts and repair to "Vendor Owned" cylinders shall not exceed 10% of the replacement values above.

The standard lease agreement provided to Praxair by the SC State Division of Procurement Services must be used with all subsequent equipment leases for Contract 5400009090. No other agreements signed on behalf of the State of South Carolina shall be binding. No lease agreement shall exceed the contractual (effective) date of July 17, 2021.

Except as provided herein, all terms and conditions of the Contract referenced above remain unchanged and in full force and effect.
